**RESOLUTION NO. 93-252**

**WHEREAS, the Tohono O'Odham Nation is presently operating the Elderly Title VI Program under a grant with the Office of Human Development Service, Administration on Aging, for the benefit of its elder members of the Nation; and**

**WHEREAS, funding for the operation of the Elderly Program has been possible in part by Article VI of the Older American's Act of 1965 as amended; and**

**WHEREAS, the Tohono O'Odham Nation has been informed by the finding agency of additional funding in the amount of \$17,314.00; and**

**WHEREAS, any amendments affecting the finding level of the grant with the Office of Human Development, Administration on Aging shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the Tohono O'Odham Elderly Program**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the amendment and authorizes expenditures in accordance the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials to wit: the**

(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).




