**WHEREAS, the Tohono O'Odham Nation is presently operating the  
Management of Health Services Program under FY 1993 P. L.  
93-638 contract with the Indian Health Services; and**

**WHEREAS, any amendments affecting the funding or funding levels of the  
contract shall be submitted for review and approval by the  
Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by  
the Management of Health Services Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the amendment  
to the Management of Health Services Program contract and  
authorizes expenditures in accordance with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
that the Tohono O'Odham Nation's Officials, to wit: the  
Chairman and any designated official are hereby authorized to  
negotiate and execute the contract, provided, however that any  
amendments affecting the funding or funding levels of this  
contract shall be submitted for further prior approval by this  
Council.**






