(FY 1993 Auto Mechanics Proposal)**

RESOLUTION NO. 93-262

WHEREAS, the Tohono O'Odham Nation has consistently supported the operation of the Tohono O'Odham Career Center; and

WHEREAS, the Nation has been informed of funding in the amount of \$50,000.00 by the Federal Transit Administration, Urban Mass Transportation Administration; and

WHEREAS, funds are to be used for training in skilled craft positions bus maintenance and repair; and

WHEREAS, the Tohono O'Odham Career Center has submitted for review and approval an FY-93 Proposal entitled: Auto Mechanic Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the FY-93 Auto Mechanic Program Proposal.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been approved by the Federal Transit Administration, Urban Mass Transportation.


BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the

(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
