

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Advocate Program Budget Modification)**

**RESOLUTION NO. 93-267**

**WHEREAS, the Tohono O'Odham Nation is currently operating the Advocate Program with tribal funds; and**

**WHEREAS, amendments affecting the funding level or change in the purpose for which the funds were budgeted are required to be submitted for review and approval by the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval to transfer funds between line items.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves this amendment and authorizes expenditures in accordance with the attached budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 19TH day of JULY, 1993 at a meeting at which a quorum was present with a vote of 1,133.0 FOR; 178.0 AGAINST; 162.0 NOT VOTING; and 290.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
