

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Override Veto of Resolution No. 93-271 "Recommending Steps  
& Procedures to be Implemented by the Chairman of the Nation  
on Proposed Administrative Plan)**

**RESOLUTION NO. 93-274**

**WHEREAS, the Tohono O'Odham Legislative Council did by Resolution No. 93-271 recommend steps and procedures to be implemented by the Chairman of the Nation on the proposed Administrative Plan; and**

**WHEREAS, upon presentation of Resolution No. 93-271 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 93-271.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of Resolution No. 93-271 by a vote of two-thirds of the votes cast.**

**The foregoing Resolution was presented to the Tohono O'Odham Council on the 2ND. day of AUGUST, 1993 at a meeting at which a quorum was present and, by a vote of 1,248.0 FOR; 439.5 AGAINST; 75.5 NOT VOTING; and 02 ABSENT, was passed by a majority of at least TWO-THIRDS (2/3) 1,125.0 of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.**


