NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation does authorize and allocate Thirty-Nine Thousand Five Hundred and Twenty-Four Dollars (\$39,524.00) to be utilized in the hiring of staff to begin the planning and seeking of funding support for the design and construction of a nursing home for the Nation.
