**RESOLUTION NO. 93-275**

**WHEREAS, the Legislative Council did, at its meeting of July 12, 1993,  
discuss and agree that in order for the Tohono O'Odham  
Nursing Home Project to be a success, the Nation should  
provide adequate funding to support the planning and seeking  
of funds for the construction of a nursing home; and**

**WHEREAS, the Legislative Council further recognizes that in order for the  
nursing home to become a reality, funds must be committed and  
set aside to insure a secure funding source for the nursing home;  
and**

**WHEREAS, the Nation is still committed to constructing and operating a  
nursing home to meet the needs of the elderly and members of  
the Nation in need of nursing care.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation  
does authorize and allocate Thirty-Nine Thousand Five Hundred  
and Twenty-Four Dollars (\$39,524.00) to be utilized in the  
hiring of staff to begin the planning and seeking of funding  
support for the design and construction of a nursing home for  
the Nation.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 2ND. day of AUGUST, 1993 at a meeting at which a quorum was present with a vote of 1,638.5 FOR; -0- AGAINST; 124.5 NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


