3 **WHEREAS, the Tohono O'odham Nation, through its Research and Planning**
4 **Department did submit a proposal to the Department of**
5 **Environmental Protection Agency (EPA) applying for funding**
6 **toward the Multi-Media Program; and**

8 **WHEREAS, the Tohono O'odham Nation, through its Research and Planning**
9 **Department did have a series of meetings with Departments,**
10 **Districts, and individuals concerned with various areas in the**
11 **area of Environmental issues; and**

13 **WHEREAS, the Tohono O'odham Nation has submitted this application to**
14 **address the need for the Nation to identify: 1) Aquifers,**
15 **information on groundwater quality, location and other physical**
16 **and hydrological statistics; 2) Identify all known wellheads and**
17 **conduct site inspections; 3) Inventory all potential pollution**
18 **point source discharges and nonpoint source discharges that may**
19 **potentially contaminate the groundwater; and 4) Establish an**
20 **ad-hoc committee composed by various tribal resources and**
21 **other resources to determine the appropriate way to proceed to**
22 **address the SARH Title III for Region IX Tribes, as well as**
23 **other concerns identified in the multi-media workplan; and**


