RESOLUTION NO. 93-286

**WHEREAS, the Tohono O'odham Legislative Council approved a
Consultant Contract with Fain P. Gildea for the purpose of
assisting the Nation in the development of a Comprehensive
Tribal Water Code; and**

**WHEREAS, the Tohono O'odham Legislative Council appropriated funds
from dividends and interest in the Trust Fund established
under Section 309 of the Southern Arizona Water Rights
Settlement Act of 1982 (SAWRSA Trust Fund) (Resolution No.
92-090) to fund the Consultant Contract; and**

**WHEREAS, the Tohono O'odham Legislative Council directed the Water
Resources Committee to conduct additional meetings on the
Comprehensive Tribal Water Code with the eleven Districts of
the Nation; and**

**WHEREAS, the Water Resources Committee did recommend that a new
contract be approved for the purpose of completing the Water
Code in the amount of \$25,000 to cover additional time and
assistance from the Consultant.**

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves
a Consultant Contract, in the form attached, with Fain P.**



2. The sum of \$25,000 is hereby appropriated from the
SAWRSA Trust Fund for the Consultant Contract with
Fain P. Gildea effective October 01, 1993 through
September 30, 1994.

The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 4TH day of AUGUST, 1993 at a meeting at which a quorum
was present with a vote of 1,394.0 FOR; 190.0 AGAINST; 179.0 NOT
VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by
Section 1(d)(2) of Article VI and Section 2 of Article XVII of the Constitution
of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
Act of June 18, 1934 (48 Stat. 984).


