

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Equal Distribution of Royalties to Districts)**

**RESOLUTION NO. 93-294**

**WHEREAS, during the August 6, 1993 General Session of the Legislative Council, the Chief Financial Officer (CFO) appeared before the Council and presented a status report regarding funds available for distribution and has attested that there is presently on deposit in interest bearing accounts established pursuant to Ordinance No. 55, and amended by Ordinance No. 13-82, a sum in excess of \$1,012,029.00; and**

**WHEREAS, it is the recommendation of the Budget & Finance Committee of the Legislative Council that the funds available for distribution be equally distributed to the eleven (11) Districts of the Tohono O'Odham Nation.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby appropriate from the foregoing accounts the sum of \$1,012,029.00 which shall be equally divided and distributed in full to each of the eleven (11) Districts of the Tohono O'Odham Nation, as follows:**

**BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that it does hereby direct the Accounting Department to transfer in full from the Accounts established pursuant to Ordinances No. 55 and No. 13-82 to the respective Accounts of each Districts the sums allocated to them pursuant to this resolution.


**BE IT FINALLY RESOLVED** that no funds be withheld from the Districts as payment for the receivables, as it is the desire of the Legislative Council that the Accounting Department continue to meet with the respective Districts to clarify the receivables for payment.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH day of AUGUST, 1993 at a meeting at which a quorum was present with a vote of 1,000.0 FOR; 763.0 AGAINST; -0- NOT


