**RESOLUTION NO. 93-297**

**WHEREAS, the Constitution of the Tohono O'Odham Nation in Article VII -  
Executive Branch, Section 2(a) mandates the Chairman to  
oversee the administration and management of the tribal  
government in accordance with an administrative plan adopted  
by the Tohono O'Odham Council; and**

**WHEREAS, through the leadership of Chairman Sylvester Listo, a proposed  
Administrative Plan has been developed and presented to the  
Legislative Council for consideration and adoption; and**

**WHEREAS, the Chairman is desirous of obtaining public education,  
comment and response to the proposed Administrative Plan; and**

**WHEREAS, the Chairman recommends to the Legislative Council that a  
period of community dialogue begin now and conclude on  
September 30, 1993, which will allow us, as a Nation, through  
meetings in each of the Nation's Districts, with additional  
information from program staff, to freely and openly discuss  
common goals and common strategies which will improve our  
ideas so that our unified work will be productive; and**

**WHEREAS, the Chairman has pledged to be responsive to the ideas of the  
Nation, to listen to community needs and concerns.**



NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby  
endorses and concurs with the process of obtaining public  
education, comment and response to the proposed  
Administrative Plan through meetings in each of the Nation's  
Districts, with additional information from program staff.

The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 16TH. day of AUGUST, 1993 at a meeting at which a quorum  
was present with a vote of 1,714.0 FOR; -0- AGAINST; 49.0 NOT  
VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by  
Section 1(c)(2) of Article VI of the Constitution of the Tohono O'Odham  
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).






