(Amending Council's Agenda - August 16, 1993)**

**LEGISLATIVE ORDER NO. 93-298**

2 **WHEREAS, on Monday, August 16, 1993, the Tohono O'odham Legislative**  
3 **Council met in a Special Meeting to review the Administrative**  
4 **Plan proposed by the Nation's Chairman; and**

15 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham**



26 **Section 1(b) of Article VI of the Constitution of the Tohono O'Odham**  
27 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**  
28 **approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
**(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**  
**1934 (48 Stat. 984).**
