(Base Roll Addition)**

3 **WHEREAS, Section 1 (a) of Article II of the Constitution of the**  
4 **Tohono O'Odham Nation provides that the Tohono O'Odham**  
5 **Council can make additions and changes to the official census**  
6 **rolls of the Sells and Gila Bend Reservations dated January 1,**  
7 **1937 and of the San Xavier Reservation dated January 1, 1940,**  
8 **subject to the approval of the Secretary of the Interior; and**

11 **WHEREAS, the Enrollment Committee has determined that the following**  
12 **named person(s) was a member of the Tohono O'Odham Nation**  
13 **on the date of the respective census rolls but that their name had**  
14 **been inadvertently omitted therefrom, and had recommended**  
15 **that their name be added to the rolls; and**

16  
17 **WHEREAS, the Tohono O'Odham Council has reviewed the recommendations**  
18 **of the Enrollment Committee and approves thereof.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council**  
21 **that, subject to the approval of the Secretary of the Interior, the**  
22 **name of the following person be added to the official census rolls**  
23 **of the Sells, Gila Bend or San Xavier Reservation, to wit:**

The foregoing Resolution was passed by the Tohono O'Odham Council on the 13TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,714.0 FOR; -0- AGAINST; 49.0 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




