RESOLUTION NO. 93-307

WHEREAS, the Sells District Council did approve by Resolution No. SD-57-93 their FY 1994 District Budget in the amount of Two Hundred Ninety-Nine Thousand Seventy-Three and No/100 Dollars; and

WHEREAS, the FY 1994 budget and budget period would be from October 1, 1993 to September 30, 1994; and

WHEREAS, the Sells District Council did review and discuss the needs of the people of Sells District, the need to have a District Administration budget and the four communities within the Sells District; and

WHEREAS, the Sells District does have sufficient funds in their account to cover their proposed budget; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Sells District proposed budget and budget justifications which are attached and finds it in order.




