on July 07, 1993 and did approve the District Resolution No.  
ST-07-07-93-03 for FY-94 Budget in the amount of \$276,078.54;

**WHEREAS, the Schuk Toak District Council requests the Legislative Council  
to ratify the budget; and**

**WHEREAS, the budgeted amount, upon ratification, be allocated to be  
expended in accordance with the attached approved budget.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the FY-94  
Budget of the Schuk Toak District, in the amount of \$276,078.54  
to be expended in accordance with the attached budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 13TH day of SEPTEMBER, 1993 at a meeting at which a  
quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT  
VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by  
Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham  
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).**
