WHEREAS, the Chukut Kuk District Council has considered and reviewed its proposed activities for FY-94 and has prepared a budget to cover anticipated costs and expenses; and


WHEREAS, the Chukut Kuk District Council did adopt the proposed budget to start on October 1, 1993 and end on September 30, 1994; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed the proposed budget in the amount of \$92,000.00, and approves same.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Chukut Kuk District Council Budget in the amount of \$92,000.00 to be expended in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
