Employment Assistance Program under FY 1993 P. L. 93-638
contract with the Bureau of Indian Affairs; and**

**WHEREAS, any amendments affecting the funding or funding levels of the
contract shall be submitted for review and approval by the
Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment as been submitted for review and approval by the
Employment Assistance Program to reflect Fiscal Year 1992
carryover funds.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council does hereby approve the amendment to the
Employment Assistance Program contract and requests the
Bureau of Indian Affairs to carry over unexpended funds from
FY 92 into FY 93 and authorizes expenditures in accordance
with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
that the Tohono O'Odham Nation's Officials, to wit: the
Chairman and any designated Official are hereby authorized to
negotiate and execute the contract, provided however, that any
