**RESOLUTION NO. 93-317**

**WHEREAS, the Tohono O'Odham Nation is presently operating the  
Community Health Services Program under FY 1993 P. L.  
93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, notification was received from Indian Health Services advising  
the Tohono O'Odham Nation that Fiscal Year 1993 non-  
recurring Health Promotion and Disease Prevention Program  
funds in the amount of \$5,080.00 are available; and**

**WHEREAS, a budget has been submitted for review and approval by the  
Community Health Services Program for the Health Promotion  
and Disease Prevention funds.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve and request  
Indian Health Services to modify the Community Health Services  
Contract No. 249-93-0002 to incorporate the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
that the Tohono O'Odham Nation's Officials, to wit: the  
Chairman and any designated Official are hereby authorized to  
negotiate and execute the contract, provided however, that any  
amendment affecting the funding or funding levels of this**

contract shall be submitted for further prior approval by this  
Council.


