

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 93 Judicial Services Program - Budget Modification No. 1)**

RESOLUTION NO. 93-321

WHEREAS, the Tohono O'Odham Nation is presently operating the Judicial Services under FY 1993 P. L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment as been submitted for review and approval by the Judicial Services to reflect Fiscal Year 1992 carryover funds.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Judicial Services Program contract and requests the Bureau of Indian Affairs to carry over unexpended funds from FY 92 into FY 93 and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated Official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of the



The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 15TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


