3 **Distribution Program under an FY 1993 Grant with the United**
4 **States Department of Agriculture; and**

6 **WHEREAS, notification was received from the United States Department of**
7 **Agriculture advising the Tohono O'odham Nation that \$4,400.00**
8 **has been earmarked for the purchase of computer equipment**
9 **which will enable the Nation to implement the nationwide**
10 **computerized Commodity Inventory System for all Food**
11 **Distribution Programs; and**

14 **WHEREAS, any amendments affecting the funding or funding levels of the**
15 **grant shall be submitted for review and approval by the Tohono**
16 **O'odham Legislative Council; and**

18 **WHEREAS, an amendment has been submitted to reflect the \$4,400.00 to**
19 **purchase the computer equipment necessary to implement the**
20 **nationwide computerized system.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
23 **Legislative Council does approve the amendment and authorizes**
24 **expenditures in accordance with the attached budget submitted**
25 **by the Food Distribution Program.**






