4 **Branch with tribal funds; and**


5 **WHEREAS, any amendments affecting the funding level or change in the**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham**
13 **Legislative Council does hereby approve the amendment to**
14 **transfer funds between line items and authorizes expenditures in**
15 **accordance with the attached budget.**

18 **Council on the 15TH day of SEPTEMBER, 1993 at a meeting at which a**
19 **quorum was present with a vote of 1,706.5 FOR; -0- AGAINST; 56.5 NOT**
20 **VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'Odham**
22 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**
23 **approved by the Acting Deputy Assistant Secretary - Indian Affairs**
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
