

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Lucy District FY-93 Budget Continuation)**

RESOLUTION NO. 93-330

WHEREAS, the San Lucy District currently is in the process of reviewing financial needs for Fiscal Year 1994; and

WHEREAS, the District Council is considering implementing one or more projects which will impact on the proposed FY 1994 budget; and

WHEREAS, said proposed projects, if implemented, will require agreements with departments within the Nation or organizations exterior to the Nation; and

WHEREAS, the details of said agreements have not been finalized to date; and

WHEREAS, the San Lucy Council approved District Resolution No. 09-51-93 on September 3, 1993 requesting the Tohono O'odham Legislative Council to consider adopting a resolution permitting the San Lucy District to continue operations under the financial conditions specific in the District's FY-1993 budget; and

WHEREAS, the District has stipulated that the San Lucy's FY-1994 budget review process will be completed prior to October 1, 1993, wherein, said budget request will be forwarded to the appropriate Legislative review committee for consideration; and

WHEREAS, the Tohono O'odham Legislative Council has considered San Lucy District Council Resolution No. 09-51-93 requesting




