3 **WHEREAS, the Tohono O'odham is a federally-recognized Tribe with**  
4 **concerns for Tribal transportation needs; and**

5 **WHEREAS, many Tribes do not have sufficient financial resources or**  
6 **professional staffs to adequately monitor transportation needs**  
7 **and development to the new provisions afforded them by the**  
8 **Intermodal Surface Transportation Efficiency Act of 1991**  
9 **(ISTEA); and**

12 **WHEREAS, at the "Conference on Exploring Solutions to Native American**  
13 **Transportation and Economic Development Problems" held in**  
14 **May 1993, Tribal leaders expressed the need to create an**  
15 **organization that would permit them to communicate with all**  
16 **Tribes on transportation issues and that would represent Tribal**  
17 **transportation concerns at state, regional and national levels.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**  
21 **Nation recognizes and supports the formation of the Intertribal**  
22 **Transportation Ad Hoc Committee and appoints Larry Garcia**  
23 **to represent the Tribe as a voting member of that Committee.**

25 **BE IT FURTHER RESOLVED that Andrew Patricio be designated as the**  
26 **alternate representative to Intertribal Transportation Ad Hoc**  
27 **Committee.**




