**WHEREAS, the Tohono O'odham Nation is presently operating the  
Community Health Representative Program under an FY 1993  
P.L. 93-638 Contract; and**

**WHEREAS; notification was received from Indian Health Service advising  
the Tohono O'odham Nation that Fiscal Year 1993 Non-  
recurring Fetal Alcohol Syndrome/Fetal Alcohol Effects  
(FAS/FAE Program funds in the amount of \$10,000 are  
available; and**

**WHEREAS, a budget has been submitted for review and approval by the  
Community Health Services Program for FAS/FAE Prevention  
Funds.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
Legislative Council hereby approves and requests the Indian  
Health Services to modify the Community Health Services  
Contract No. 249-93-0002 to incorporate the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
that the Tohono O'odham Nation's Officials, to wit: The  
Chairman and any designated official are hereby authorized to  
negotiate and execute the contract, provided however, that any  
amendments affecting the funding or funding levels of this**



contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH day of September, 1993 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


