8 **Child Welfare Act - Family Preservation Program proposal;**

11 **WHEREAS; after discussions, notification was received that Fiscal Year**
12 **1992 ICWA Grants will be extended for all grantees with 65%**
13 **of the 1992 grant funding level; and**

15 **WHEREAS, any amendments affecting the funding or funding levels of the**
16 **grant shall be submitted for review and approval by the**
17 **Tohono O'odham Legislative Council; and**

19 **WHEREAS, an amendment has been submitted for review and approval by**
20 **the Social Services Program.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
23 **Legislative Council does hereby approve the amendment to the**
24 **Family Preservation Program Grant No. 1450GTH64T61030**
25 **and requests the Bureau of Indian Affairs to extend the grant**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 17TH day of September, 1993 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


