3 **WHEREAS, the Tohono O'odham Nation is presently operating the JTPA**  
4 **Title IIB Program under FY 1993 Contract with the State of**  
5 **Arizona Department of Economic Security; and**

7 **WHEREAS, any amendments affecting the funding or funding levels of the**  
8 **contract shall be submitted for review and approval by the**  
9 **Tohono O'odham Legislative Council; and**

11 **WHEREAS, an amendment has been submitted for review and approval by**  
12 **the JTPA Title IIB Summer Youth Employment Training**  
13 **Program to reflect calendar year 1992 carry over funds.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**  
16 **Legislative Council does hereby approve the amendment to the**  
17 **JTPA Title IIB Program and authorizes expenditures in**  
18 **accordance with the attached budget.**

20 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council**  
21 **that the Tohono O'odham Nation's Officials, to wit: The**  
22 **Chairman and any designated official are hereby authorized to**  
23 **negotiate and execute the contract, provided however, that any**  
24 **amendments affecting the funding or funding levels of this**  
25 **contract shall be submitted for further prior approval by this**  
26 **Council.**
