WHEREAS, the Tohono O'odham Nation is presently operating the JTPA/JOBS Title II Program funded by the Department of Health and Human Services, Family Support Administration (DHHS/FSA); and

WHEREAS, the Nation has been informed of its final allocation for FY 1993 JOBS Program in the amount of \$147,599; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the JTPA/JOBS Title II Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the amendment to the JTPA/JOBS Title II Program and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: The Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.


