**WHEREAS, the 1993 fiscal year ends at midnight, September 30, 1993 and
all spending authority granted under the 1993 budgets ends at
that time; and**

**WHEREAS, the continued operation of the Judicial Branch of the Tohono
O'Odham Nation requires adoption of an operating budget, the
grant of spending authority and the appropriation of funds for
FY 1994; and**

**WHEREAS, the Judicial Branch of the Nation has prepared and presented a
budget that reflects the need of the Branch, said budget is
attached hereto and incorporated by reference; and**

**WHEREAS, the Budget & Finance Committee of the Legislative Council of
the Tohono O'Odham Nation has reviewed this budget and
recommended its approval and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the
Tohono O'Odham Nation that it approves the FY 1994 budget
submitted by the Judicial Branch. It is recognized that Payroll
Taxes for Judicial Branch employees, in the amount of 10% of
budgeted salaries are included in this budget. An additional
amount equal to 16% of budgeted salaries is budgeted for
Employee Benefits for Judicial Branch employees as part of the**

BE IT FURTHER RESOLVED that funds in the amount of \$1,040,204., are appropriated and authorized to be expended from sources of funding approved by this Council for support of the FY 1994 budgets of the Tohono O'Odham Nation


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 27TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,183.0 FOR; 151.0 AGAINST; 136.0 NOT VOTING; and 293.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


