14 **Legislative Council hereby concurs and approves the request of**
15 **the Pisinemo District to continue to incur costs at its FY '93 level**

24 **Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono**
25 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,**
26 **1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
27 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
28 **1934 (48 Stat. 984).**


