

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Baboquivari District FY 1994 Budget)**

RESOLUTION NO. 93-350

WHEREAS, the Baboquivari District Council has determined that in order for its administration and villages to function adequately, additional funding is necessary; and


WHEREAS, the total budget for FY 1994 is \$316,296.75, this amount exceeds the District distribution by \$224,294.11; and

WHEREAS, the Tohono O'Odham Legislative Council within its power to appropriate funds have reviewed and approved the proposed budget of the Baboquivari District Council in the amount of \$316,296.75

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appropriate the difference of \$224,294.11 to supplement the District distribution of \$92,002.64 to fund the total amount of \$316,296.75, for the Baboquivari District Council budget for Fiscal Year 1994.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 29TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,499.0 FOR; -0- AGAINST; 136.0 NOT VOTING; and 128.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


