

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption of the Gu-Vo District FY '94 Budget )**

**RESOLUTION NO. 93-353**

**WHEREAS, the Gu-Vo District Governing Council did on September 28, 1993 meet in a Special Session to review and adopt the District Budget; and**

**WHEREAS, the Gu-Vu District Council did approve the District budget in the amount of Two Hundred Fifty-Three Thousand Three Hundred Thirty-Four Dollars (\$253,334.); and**

**WHEREAS, the Gu-Vo District only has One Hundred Thousand Dollars (\$100,000.) to pay for a proportion of said budget; and**

**WHEREAS, the Gu Vo Council is asking the Tohono O'Odham Nation for the additional funds; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Gu-Vo District Budget and finds it in order.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Gu-Vo District FY '94 Budget in the amount of \$253,334.00 and authorizes expenditures in accordance therewith.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby appropriates supplemental funding in the amount of \$153,334 to support the total budget of \$253,334.00 .**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 29TH day of SEPTEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,549.5 FOR; -0- AGAINST; 213.5 NOT**
