

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Continue Executive Branch Operations)**

RESOLUTION NO. 93-354

WHEREAS, the Executive Branch is unable to forwards its FY '94 approved budgets to the Tohono O'Odham Legislative Council (TOLC) before the legislature concludes its Special Council Session for FY '93; and

WHEREAS, it is in the best interest of the Executive Branch to continue its fiscal operations pending the review and approval of its FY '94 budgets by the Tohono O'Odham Legislative Council; and

WHEREAS, in order that programs and services provided will not be interrupted, the Executive Branch is requesting an extension, not to exceed 60 days, to sumit the FY '94 budgets.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby authorize the Executive Branch to continue operations, at current spending levels, in order that programs and services will not be interrupted.

BE IT FURTHER RESOLVED that this interim period will not exceed 60 days or until the November 1993 regular Legislative Council Session.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 29TH day of September, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






