

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving TOUA Utility Easement for a New  
Transmission Line to the Pisinemo Village)**

**RESOLUTION NO. 93-362**

**WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a new utility easement for a new transmission line to the Pisinemo Village, Pisinemo District, and has submitted a plat or map thereof to the Tohono O'Odham Council showing the location and scope of the easement and delineating the utility facilities to be placed thereon; and**

**WHEREAS, the Tohono O'Odham Council has determined that the routing and location of the easement for all required utility services is not in conflict with any land use plans adopted by the District Council and approved by the Tohono O'Odham Council, and that the new transmission line will be of substantial benefit to the Pisinemo Community, District, and the Tohono O'Odham Nation and to their respective members.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Council does hereby approve the easement for the location and construction by the TOUA of the new transmission line and all required utility services to serve the Pisinemo Community, Tohono O'Odham Nation.**


