**WHEREAS, the Papago Council adopted the Plan of Operation of the Papago Farming Authority on August 24, 1979, pursuant to Resolution No. 72-79; and**

**WHEREAS, it was amended and restated by the Tohono O'Odham Legislative Council on August 10, 1990, pursuant to Resolution No. 283-90; and**

**WHEREAS, the Tohono O'Odham Farming Authority is responsible for the management and operation of the Tohono O'Odham Farms under section 6:2, 6:3 to fulfill purposes set forth in section 4 of the Restated Plan of Operation; and**

**WHEREAS, the Tohono O'Odham Farming Authority is in serious violation of the Plan of Operation section 6:9 and section 20:E for failure to comply with the requests made on behalf of the Agriculture Committee of the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby support Sif-Oidak District Council Resolution No. 15-93, on the suspension of the Tohono**

as the interim Tohono O'Odham Farming Authority to conduct  
the investigation.

**BE IT FURTHER RESOLVED** that the Tohono O'Odham Legislative Council  
recommends that the General Manager be put on leave pending  
the investigation.

**BE IT FINALLY RESOLVED** that the interim Tohono O'Odham Farming  
Authority report its findings to the Tohono O'Odham Legislative  
Council and the Sif Oidak District within 60 days.


The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 11TH day of OCTOBER, 1993 at a meeting at which a  
quorum was present with a vote of 1,419.0 FOR; 276.0 AGAINST; 68.0  
NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the  
Council by Section 1(b) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
