8 **to do a study within the Nation; and**

10 **WHEREAS, after the study, any person known to have epilepsy can get a**
11 **closer examination by Dr. Labiner and staff to provide adequate**
12 **medical assistance; and**

14 **WHEREAS, any person known to have epilepsy can participate in the**
15 **medical study at the University; and**

16 **WHEREAS, following the meeting with Dr. Labiner, the Health & Human**
17 **Services Committee recommended to approve his request to**
18 **conduct an epilepsy study within the Tohono O'odham Nation.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
21 **Legislative Council hereby grants approval to the University of**
22 **Arizona Health Sciences Center to conduct a study of epilepsy**
23 **within the Tohono O'odham Nation.**

25 **BE IT FURTHER RESOLVED that the University of Arizona Health Sciences**
26 **Center's Dr. David M. Labiner will follow-up and provide**
27 **adequate results to the Tohono O'odham Nation.**






