(Tabling approval of Tohono O'Odham Farm Board Authority Members)**

RESOLUTION NO. 93-374

WHEREAS, the Tohono O'Odham Farm Authority Plan of Operation calls for the appointment of the Management Board by the Chairman of the Tohono O'Odham Nation, with the approval of the Tohono O'Odham Legislative Council; and

WHEREAS, the terms of office for some of the Management Board have expired; and

WHEREAS, the Chairman of the Tohono O'Odham Nation did submit names for confirmation by the Legislative Council for approval; and

WHEREAS, by Resolution No. 93-364, the Legislative Council, did suspend the Tohono O'Odham Farming Authority Board for investigation of concerns addressed; and

WHEREAS, a concern was voiced by several members of the Legislative Council regarding the previous action of the Council to conduct an investigation on the Farm Board; and

WHEREAS, due to the pending action it was recommended that the Farm Board Appointments be tabled.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby tables the approval of the Tohono O'Odham Farm Board Authority Members.

11 1934 (48 Stat. 984).


