**WHEREAS, the Legislative Council shall authorize funds for the Director of
Government Operations and the Executive Assistant to be
appointed by the Chairman; and**

**WHEREAS, the aforementioned appointments will be at the discretion of the
Chairman of the Tohono O'Odham Nation; and**

**WHEREAS, the aforementioned appointments are exempt from the Tohono
O'Odham Legislative Council confirmation process; and**

**WHEREAS, the aforementioned appointments will receive the full benefits as
afforded to all employees of the Tohono O'Odham Nation; and**

**WHEREAS, the funding will be negotiated by the Chairman of the Tohono
O'Odham Nation and will be included in the Executive
Administration budget as permanent line items.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that funding will be authorized for the
positions of Director of Government Operations and the
Executive Assistant to the Chairman, to be appropriated to the
Executive Office Administration, beginning in the FY 1994
Executive Budget.**



afforded to all employees of the Tohono O'Odham Nation


The foregoing Resolution was presented to the Tohono O'odham Council on
the 19TH day of OCTOBER, 1993 at a meeting at which a quorum was
present, and by a vote of 687.0 FOR; 940.0 AGAINST; 136.0 NOT
VOTING; AND 04 ABSENT, **failed to pass** because it did not receive a
majority of the votes cast as required by Section 2 of Article V of the
Constitution of the Tohono O'Odham Nation.
