3 **WHEREAS, the Constitution of the Tohono O'Odham Nation, Article VII.,**

5 **Section 2. (a) mandates the Chairman of the Tohono O'Odham**
6 **Nation to develop an Administrative Plan, hereafter known as**
7 **the Plan, to be approved by the Tohono O'Odham Legislative**
8 **Council; and**

10 **WHEREAS, an Administrative Plan Development Team, hereafter known as**
11 **the APDT, was organized and Chaired by the Chairman of the**
12 **Tohono O'Odham Nation to assist with the development of the**
13 **Plan; and**

15 **WHEREAS, the APDT involved Executive Branch employees in a process to**
16 **develop the Plan; and**

18 **WHEREAS, on August 16, 1993 the Chairman of the Tohono O'Odham**
19 **Nation called a special session of the Legislative Council to**
20 **present his Plan and introduce his Political Appointees, hereafter**
21 **known as the Appointees; and**

23 **WHEREAS, the Chairman of the Tohono O'Odham Nation introduced a**
24 **Resolution, approved by the Legislative Council as No. 93-297,**
25 **entitled "Accepting Procedures for Community Presentations of**
26 **the Proposed Administrative Plan by the Chairman of the**
27 **Tohono O'Odham Nation". This allowed time for community**

approved by the Legislative Council.


The foregoing Resolution was presented to the Tohono O'odham Council on

present, and by a vote of 226.0 FOR; 1,401.0 AGAINST; 136.0 NOT
VOTING; AND 03 ABSENT, **failed to pass** because it did not receive a
majority of the votes cast as required by Section 2 of Article V of the
Constitution of the Tohono O'Odham Nation.
