

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with California
Indian Legal Services)**

RESOLUTION NO. 93-382

WHEREAS, by Resolution No. 93-290 the Tohono O'odham Legislative Council approved an attorney contract with California Indian Legal Services to provide legal representation with respect to certain cases arising in California under the Indian Child Welfare Act ("ICWA"); and

WHEREAS, the attorney contract expired on September 30, 1993; and

WHEREAS, continued representation regarding ICWA matters in California is required to protect the Nation's interests; and

WHEREAS, the proposed budget of the Office of Attorney General for fiscal year 1994 requests funding of \$10,000 for attorney contracts in ICWA cases; and

WHEREAS, the budgets for the Office of Attorney General and executive programs have not been presented to the Legislative Council; and

WHEREAS, appropriating funds for an extension of the attorney contract will avoid interruption in needed legal services; and

WHEREAS, the Domestic Affairs Committee recommends approval of an amendment which extends the attorney contract for fiscal year 1994.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the Attorney Contract with California Indian Legal Services in the amount of \$5,000 for the fiscal year ending September 30, 1994 and in the form attached hereto.**
- 2. The Legislative Council appropriates the sum of \$5,000 from the General Revenue Account to pay fees and expenses under Amendment No. 1. The amount appropriated shall be a part of the budget of the Office of Attorney General for fiscal year 1994.**
- 3. The Chairman of the Nation is authorized and directed to execute Amendment No. 1.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH day of OCTOBER, 1993 at a meeting at which a quorum was present with a vote of 1,639.0 FOR; -0- AGAINST; -0- NOT VOTING; and 124.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
