

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 93-351 "Support of Community
Newspaper for the Tohono O'Odham Nation)**

RESOLUTION NO. 93-386

WHEREAS, the Legislative Council did by Resolution No. 93-351 support the recommendation by the Chukut Kuk District that a newspaper for the Tohono O'Odham Nation would be beneficial for its members and allocated such funds necessary to carry out this proposal; and

WHEREAS, this paper would dedicate a section for each district, if they so desired, for publication of information for their respective districts in order to keep its members informed of activities and events; and

WHEREAS Resolution No. 93-351 failed to make clear that these funds would be allocated specifically for the community news section of Stanley Throssell's Newspaper as intended by the Tohono O'Odham Legislative Council; and

WHEREAS, said Resolution did not state where funds would be allocated from.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby rescinds Resolution No. 93-351 "Support of Community Newspaper for the Tohono O'Odham Nation".

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH day of OCTOBER, 1993 at a meeting at which a quorum was present with a vote of 1,459.0 FOR; -0- AGAINST; -0- NOT VOTING; and 304.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






