RESOLUTION NO. 93-398

**WHEREAS, the San Simon Community in the Pisinemo District has
requested funding for an infrastructure from DHUD-ICDBG for
FY 1993; and**

**WHEREAS, the cost and technical expertise required to Operate and
Maintain (O&M) Community wide systems are such that it is
not feasible for the Communities and/or Districts to assume
O&M of the systems; and**

**WHEREAS, TOUA has the technical expertise and resources required to
provide adequate O&M of such systems; and**

**WHEREAS, it is in the best interests of the San Simon Community of the
Pisinemo District and the Tohono O'odham Nation that O&M
be provided by TOUA.**

**NOW, THEREFORE, BE IT RESOLVED that the San Simon Wastewater be
turned over to TOUA, to provide O&M of the systems, once the
project is completed and operational.**

**BE IT FURTHER RESOLVED that TOUA is hereby granted Right-of-Way
in order to allow maintenance and operation of the wastewater
system.**




