4 **Tohono O'Odham Nation pursuant to Section 2 of Article II of**
5 **the Constitution of the Tohono O'Odham Nation; and**

6 **WHEREAS, the Enrollment Committee has reviewed the respective**
7 **application, has made a final determination that SINOHUE,**
8 **Elena is 1/2 degree or more of Papago-Tohono O'Odham**
9 **Indian blood, and has made a recommendation to the Tohono**
10 **O'Odham Legislative Council that the application be approved,**
11 **all in accordance with the provisions of the Enrollment**
12 **Ordinance; and**

15 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed the**
16 **recommendations of the Enrollment Committee and the**
17 **evidence submitted in support of the individual application.**


