The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 16TH day of NOVEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,530.0 FOR; 67.5 AGAINST; 165.5 NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Sections 1(d)(1), (2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
