11 **WHEREAS, KPMG Peat Marwick has reported on the FY-92 audit to the**
12 **Executive Branch; and**

13 **WHEREAS, KPMG Peat Marwick has further presented, reported and**
14 **explained the FY-92 audit report of Papago Bingo to the**
15 **Legislative Council of the Tohono O'odham Nation.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation**
18 **does hereby accept the FY-92 audit report of Papago Bingo as**
19 **presented by KPMG Peat Marwick.**

22 **The foregoing Resolution was passed by the Tohono O'Odham Legislative**
23 **Council on the 16TH day of NOVEMBER, 1993 at a meeting at which a**
24 **quorum was present with a vote of 1,530.0 FOR; 67.5 AGAINST; 165.5**
25 **NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the**
26 **Council by Sections 1(d)(1), (2) & (3) of Article VI of the Constitution of the**
27 **Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**
28 **January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
Act of June 18, 1934 (48 Stat. 984).


