**WHEREAS, former BIA Buildings identified as #161, #162, and #163 located in the Gu Achi District were acquired by the Tohono O'odham Nation by action of the Papago Tribal Council in December of 1981 by Res. No. 168-81; and**

**WHEREAS, in subsequent years the Gu Achi District has authorized the use of said buildings for various purposes benefiting District Members; and**

**WHEREAS, in order to clarify ownership of said buildings, the Gu Achi District Council requests the transfer of the titles to the Gu Achi District.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves the transfer of titles to the Gu Achi District of buildings identified as #161, #162, and #163 located in Covered Wells, Gu Achi District.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council supports Gu Achi District Resolution #193-74 and hereby requests the Bureau of Indian Affairs (BIA) to provide an Environmental assessment statement pertaining to buildings #161, #162, and #163.**




