**RESOLUTION NO. 93-415**

**WHEREAS, the San Lucy District Council has considered and reviewed  
proposed activities for FY-94 and prepared a budget to cover  
anticipated costs and expenses; and**

**WHEREAS, the San Lucy District Council approved the proposed FY-94  
budget in the amount of \$989,065.00, to commence October 01,  
1993 and end on September 30, 1994; and**

**WHEREAS, the FY-94 District Budget segregates projected expenses per line  
item and designates expenditures which are properly attributed  
to: (1) District Governance; (2) 93-638 Substance Abuse  
Services; and (3) activities authorized under P. L. 99-503; and**

**WHEREAS, I.I.M funds in the amount of \$76,369.97 are available in the  
District's General Account at the Valley Bank to cover  
governmental functions as indicated in the budget; and**

**WHEREAS, funds in the amount of \$47,916.36 will be available from a  
93-638 Substance Abuse Contract to cover expenses related to  
the District's Alcohol and Substance Abuse Project; and**

**WHEREAS, the San Lucy District requests approval to expend P. L. 99-503  
funds in the amount of \$864,778.67 for activities authorized in  
said Public Law.**

**BE IT FURTHER RESOLVED that draw down requests shall be issued on a  
bi-weekly basis and shall be wire transferred to Account No.  
2186-1432, Bank One - Gila Bend, Arizona.**

Council on the 18TH day of NOVEMBER, 1993 at a meeting at which a  
quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT  
VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by  
Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham  
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).**
