

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Payment of Christmas Bonus)**

**RESOLUTION NO. 93-427**

**WHEREAS, the Legislative Council believes that all employees of the Tohono  
O'odham Nation's three government branches, receive a  
Christmas Bonus; and**

**WHEREAS, the Legislative Council has decided that the amount of \$500.00  
be given to each employee and official; and**

**WHEREAS, a total of 580 employees and officials will be granted the bonus;  
and**

**WHEREAS, the Legislative Council of the Tohono O'odham Nation desires  
that the bonus be paid without deduction of taxes.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
Legislative Council does hereby approve and appropriate the  
amount of \$290,000. to provide a Christmas Bonus payment to  
all employees, appointed, and elected officials from the Nation's  
three government branches.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
that the sum of \$43,000.00 be appropriated, which reflects 15%,  
to address the necessary tax withholding obligations.**

**BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council  
does hereby approve and appropriate such sums necessary from  
the Special Reserve Account to provide for Christmas Bonus payments.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 24TH day of NOVEMBER, 1993 at a meeting at which a quorum was present with a vote of 909.0 FOR; 730.0 AGAINST; 124.0 NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


