RESOLUTION NO. 93-428

**WHEREAS, the Legislative Council believes that all employees of the Tohono
O'odham Nation's Bingo and Desert Diamond Casino receive a
Christmas Bonus; and**

**WHEREAS, a total of 500 employees and officials will be granted a bonus;
and**

**WHEREAS, the Legislative Council has decided that the amount of \$500.00
be given to each employee and official; and**

**WHEREAS, the Legislative Council of the Tohono O'odham Nation desires
that the bonus be paid without deduction of taxes.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
Legislative Council does hereby approve and appropriate the
amount of \$250,000. to provide a Christmas Bonus payment to
all employees, and officials from the Nation's Desert Diamond
Casino operations.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
that the sum of \$37,500. be appropriated, which reflects 15%,
to address the necessary tax withholding obligations.**

**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council
that it does hereby approve and appropriate such sums necessary**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 24TH day of NOVEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,217.0 FOR; 346.5 AGAINST; 199.5 NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






