

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1994 JOB Opportunities Basic Skills Program)**

RESOLUTION NO. 93-430

WHEREAS, Public Law 100-485, the Family Support Act of 1988, was enacted into law on October 13, 1988 to revise the AFDC Program to emphasize work, child support, and family benefits, to amend Title IV of the Social Security Act, to encourage and assist needy children and parents under the program to obtain the education, training and employment needed to void long term welfare dependence; and

WHEREAS, on November 22, 1993 the JOBS Program was notified by the JOBS Federal Representative of FY 1994 partial allocations; and

WHEREAS, the JOBS Program has submitted a budget for Fiscal Year 1994 for review and approval.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the FY 1994 JOBS Program Budget and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided, however, that any



amendments affecting the funding or funding levels of the grant
shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 24TH day of NOVEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






