**RESOLUTION NO. 93-431**

**WHEREAS, the Tohono O'odham Nation is presently operating the Food Distribution Program under an FY 1994 Grant with the United States Department of Agriculture; and**

**WHEREAS, notification was received from the United States Department of Agriculture advising the Tohono O'odham Nation that \$18,500 has been earmarked for the purchase of a vehicle; and**

**WHEREAS, any amendments has been submitted to reflect the \$18,500 to purchase a vehicle and Revision to the Plan of Operation for review and approval by the Food Distribution Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve the amendment and authorize expenditures in accordance with the attached budget submitted by the Food Distribution Program.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Chairman and any designated Official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 24TH. day of NOVEMBER, 1993 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT**


